THINGS TO REMEMBER AND REFLECT ON IN DECEMBER:

Dec 1, 1941 - The American Civil Air Patrol (CAP), a U.S. Air Force auxiliary, was founded.

Dec 1, 1955 - The birth of the American civil rights movement occurred as Rosa Parks was arrested in Montgomery, Alabama.

Dec 2, 1823 - President James Monroe introduced his "Monroe Doctrine" prohibiting any further colonization of the American continents by European powers, stating, "we should consider any attempt on their part to extend their system to any portion of this hemisphere as dangerous to our peace and safety."

Dec 3, 1962 - Edith Sampson was sworn in as the first African American female judge.

Dec 4, 1991 - The last American hostage held in Lebanon was released. Journalist Terry Anderson kidnapped on March 16, 1985 and held for 2,454 days by the Islamic Jihad.

Dec 5, 1955 - The AFL-CIO was founded thus becoming the leading advocate for trade unions in the U.S.

Dec 6, 1865 - The 13th Amendment to the U.S. Constitution was ratified abolishing slavery, stating,

Dec 7, 1941 - The U.S. Naval base at Pearl Harbor, Hawaii, was attacked by nearly 200 Japanese aircraft in a raid that lasted just over one hour and left nearly 3,000 Americans dead.

Dec 12, 1870 - Joseph Hayne Rainey of Georgetown, South Carolina, became the first African American to serve in the U.S. House of Representatives and served until 1879.

Dec 13, 1862 - The Battle of Fredericksburg - the Union Army of the Potomac suffered a costly defeat, losing 12,653 men after 14 frontal assaults on well entrenched Rebels on Marye's Heights. Confederate losses were 5,309. "It is well that war is so terrible - we should grow too fond of it," stated Confederate General Robert E. Lee during the fighting.

Dec 15, 1791 - The Bill of Rights became effective following ratification by Virginia.

Dec 15, 1890 - Sioux leader Sitting Bull was killed in a skirmish with soldiers. as his warriors tried to prevent his arrest.

Dec 16, 1773 - The Boston Tea Party occurred as colonial activists dumped 342 containers of expensive tea into Boston Harbor.

Dec 16, 1944 - During World War II in Europe, the Battle of the Bulge began. There were an estimated 77,000 Allied and 130,000 German casualties.

Dec 17, 1777 - At Valley Forge the Continental Army settled in for the winter.

Dec 17, 1903 - Orville and Wilbur Wright achieved the first powered, controlled airplane flights. They made four flights near Kitty Hawk, North Carolina, the longest lasting about a minute.

Dec 20, 1860 - South Carolina became the first state to secede from the Union.

Dec 20, 1989 - Operation Just Cause - The U.S. invaded Panama after Noriega had declared unfavorable election results in his country to be null and void and toppled the Noriega government.

Dec 22, 1783 – General George Washington appeared before Congress and voluntarily resigned his commission.

Dec 25, 1776 – General George Washington took army across the Delaware River and conducted a surprise raid on 1,500 British-Hessians (German mercenaries) at Trenton, New Jersey. The Hessians surrendered after an hour with nearly 1,000 taken prisoner by Washington who suffered only six wounded (including future president Lt. James Monroe).

Dec 29, 1890 - Members of the 7th Cavalry massacred more than 200 Native American men, women and children at Wounded Knee Creek, South Dakota.

Dec 30, 1903 - In Chicago, a fire inside the Iroquois Theater killed 588 persons, eventually resulting in new fire safety codes for theaters.

Dec 31, 1781 - The first U.S. bank, the Bank of North America, opened on January 7, 1782, in Philadelphia.

Mr. Henry Gonzales provided a presentation at the November 21 dinner meeting of his personal relationship with The Grunt Padre". Henry described his experiences in Viet Nam while serving with Father Capodonno as

his aide and personal security. He described the tremndous service, valor and sacrifice of Father Vincent Robert Capodanno Vietnam 1966-1967. Father Capodanno was killed on his second tour of duty with the 5th Marines on



September 4, 1967. For sacrifice he was posthumous awarded Medal of Honor which was presented to his family on January 7,1969.

MILITARY PAY, TRICARE UPGRADES ON TAP WHEN CONGRESS RETURNS TO WORK

A busy agenda awaits members of Congress when they return to Washington, D.C., after the election, with the FY 2025 National Defense Authorization Act (NDAA) taking center stage.

This year's NDAA has faced significant delays as lawmakers negotiate disagreements on a multitude of military policies. As they navigate a challenging political and legislative landscape, MOAA remains closely involved with several initiatives that could have an impact on the well-being and support of the military community.

Here's a look at some of the provisions in the House and Senate NDAA versions, which include key MOAA priorities:

Military Pay Raise and Junior Enlisted Pay Increase: The House version of the NDAA calls for

a significant 15% increase for junior enlisted service members (E-1 to E-4) in addition to a standard 4.5% raise for all ranks. This proposal faces strong opposition from the White House and some in the Pentagon, and lacks corresponding provisions in the Senate's version, which only suggests a 1% additional raise for fewer junior enlisted members (E-1 to E-3).

Basic Allowance for Housing (BAH): Another critical element of the House NDAA is the effort to restore BAH to cover 100% of housing costs, a measure vital for supporting service members and their families. This initiative lacks Senate support and was not funded by the House Appropriations Committee, highlighting the challenges of securing adequate resources for military families.

Basic Allowance for Subsistence (BAS): The House NDAA mandates a comprehensive review of BAS rates by DoD. This review would consider various factors such as family size, food accessibility, and local costs, ensuring allowances accurately reflect the needs of service members and their dependents. Furthermore, the legislation proposes raising Basic Needs Allowance (BNA) eligibility to 200% of federal poverty guidelines, a move that could significantly expand support for those in need.

Military Family Support: The House version of the NDAA includes several important provisions aimed at enhancing support for military families and improving the welfare of service members:

- Expanded In-Home Child Care Pilot: The
 proposed expansion would include installations
 such as New York's Fort Drum, New Mexico's
 Holloman Air Force Base, and Naval Air
 Station Lemoore and Marine Corps Air-Ground
 Combat Center Twentynine Palms in
 California. The move would increase access to
 essential childcare services for military
 families.
- Incentives for Child Care Providers: Last year, DoD mandated that services implement policies to encourage more individuals to become childcare providers, offering a 50% discount on care for their first child. The Air Force has set a higher standard by providing a 100% discount for the first child and additional

- discounts for subsequent children. The House version of the NDAA aims to establish this 100% discount across all services, ensure competitive pay for childcare personnel, and facilitate easier transfers between installations.
- Flexibility for Federally Employed Military
 Spouses: The House version of the NDAA
 requires federal agencies to offer flexibility for
 military spouses upon receipt of PCS orders.
 Options include remote work, reassignment
 within the commuting area of the new duty
 station, authorization to perform duties in an
 equal position, or leave without pay for up to
 six months, allowing agencies to backfill
 positions.

Transition Assistance Program for Guard and Reserve: The House NDAA includes a tailored transition assistance program for Guard and Reserve members, better aligning support with their unique needs. It also would establish parental leave parity for the Coast Guard Reserve, bringing the service's policies in line with DoD procedures.

Military Unaccompanied Housing: The House NDAA calls for increased funding and visibility of Facilities Sustainment, Restoration and Modernization (FSRM) funds to address decades of deferred maintenance, estimated at \$137 billion. The proposal also includes provisions allowing junior enlisted Navy personnel on sea duty to receive BAH in response to extended ship maintenance periods.

TRICARE: Both the House and Senate NDAA versions include key provisions that would improve the military health care benefit by:

- Eliminating Contraception Copays to Align TRICARE With Affordable Care Act Requirements: To avoid direct spending barriers, the House version limits this change to one year while the Senate version delays implementation until 2034.
- Expanding TRICARE Coverage of Assisted Reproductive Technology, Including IVF: Both versions exclude certain beneficiaries, including retirees, to avoid mandatory spending increases. MOAA has urged Congress to include all beneficiaries in this parity fix.
- Including Pregnancy as a Qualifying Life Event (QLE): The House version includes a pilot that

would make this change as part of a five-year program. Greater flexibility in switching between TRICARE Prime and Select will help ensure access to vital prenatal care.

Offering More Mental Health Options: A
provision in the Senate version would allow
active duty service members and their families
to use TRICARE network mental health
providers licensed in another state. This would
help address mental health access and
continuity of care challenges for mobile
military families.

These provisions underscore the commitment to supporting military families and ensuring the well-being of service members. As lawmakers consider the NDAA, it is essential they include critical measures in the final legislation to strengthen and support the military community.

HOUSE PASSES DOLE ACT

The Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act, H.R. 8371passed in the House with a bipartisan vote of 389-9. This legislative, known as the Dole Act, is being slated for a vote in the Senate. If signed into law, it would fund a range of enhancements vital to critical health care services for veterans and

caregivers who need help now and cannot wait any longer.

HOLIDAY OVERSEAS MAIL DEADLINES APPROACHING

The U.S. Postal Service is preparing for the holiday season as many families spend holidays apart due to military service. To ensure overseas packages are delivered before Dec. 25, it has provided the following deadlines: Dec. 9 for all Air/Army Post Office (APO), Fleet Post Office (FPO) and Diplomatic Post Office (DPO) addresses with AE zip codes using Priority Mail and First-Class Mail; and Dec. 16 or APO/FPO/DPO addresses using USPS Priority Mail Express. Actual delivery dates may vary.

MILITARY RECRUITMENT RISES DESPITE ONGOING CHALLENGES

The Department of Defense (DOD) has reported it successfully recruited 12.5% more personnel in fiscal year 2024 than the previous year, increasing the number of recruits from 200,000 to 225,000. The armed services saw a rise in written contracts and a larger pool of candidates entering the delayed entry program. However, despite these gains recruitment remains challenging due to low interest among youth, a competitive job market, and a decline in eligibility of young adults. Many people who are 17 24 years of age have little to no connection to military service, and the majority would need waivers to serve. To improve awareness and understanding, DOD is launching campaigns on military service value and opportunities.
