
PRESIDENT'S COLUMN

Danny W. Smith is the Police Chief of Robinson, Texas. He served in the U.S. Army from 1966 to 1969, which included 1½ years in Vietnam. He has mainly worked for the Texas Department of Public Safety. He served in various highway patrol positions and ranks and was a Regional Commander in Dallas and a Regional Commander in Waco; this involved directing and supervising Traffic Law Enforcement Activities for 46 counties of Central Texas, Hill County, East Texas and West Texas. Duties involved supervision of over 460 employees, both Commissioned and civilian plus budgetary management and oversight, personnel issues and setting policies. He was commissioned Special Ranger for TX DPS. He served as interim Police Chief for Bellmead, Texas in 2019. He most recently served as interim Police Chief for Robinson and was appointed permanent Police Chief of Robinson in January 2023.

<u>MEMBER SPOTLIGHT – WILLIAM BAUER,</u> --FORMER CHAPTER PRESIDENT



Colonel William D. (Bill) Bauer, USMC, was born in Pensacola, FL, on March 3, 1936, where his father completed flight training. His father, Lieutenant Colonel Harold W. Bauer, USMC was a recipient of the Congressional Medal of Honor for

actions in the South Pacific during WWII. Bill spent his early years in Quantico, VA; Coronado, CA and Waco, TX. He graduated from Waco High School in 1954.

Following in his father's footsteps, Bill received a Presidential appointment to the United States Naval Academy and graduated with the class of 1958. He then embarked on a remarkable military career, becoming a Marine fighter pilot, and earning his wings in 1960. Bill served in Vietnam, flying 110 missions in the F-4 and also served with the infantry as the Air Liaison Officer to the 1st Marine Regiment at the Battle of Hue during the 1968 Tet Offensive and later at Khe Sanh.

Bill graduated from the U. S. Navy Test Pilot School in 1970, receiving the "Empire Test Pilot School" award for the top final exercise. He participated in the first and second Navy Preliminary Evaluations of the F-14 Tomcat, being the third Naval Aviator to fly the F-14, and has

flown over 40 types of aircraft. He was selected as a Member of the Society of Experimental Test Pilots for his participation in experimental and developmental flight testing. He graduated from the Navy War College in 1980, winning the Navy League's "Steven B. Luce" award for outstanding performance.

Bill's commands included Marine Fighter Attack Training Squadron 101 in Yuma, AZ; Marine Aircraft Group 15 in Iwakuni, Japan; and the Marine Aviation Detachment at the Naval Air Test Center, Patuxent River, MD. His decorations include the Legion of Merit, Distinguished Flying Cross, Bronze Star with "V," Air Medal (8th award), and Navy Commendation Medal.

Bill's personal life was equally fulfilling. His crowning achievement was marrying Judy, a girl he met while having breakfast at an Officer's Club in Tokyo in 1962. Judy, a former Kansas State Homecoming Queen, and runner-up Miss Kansas, caught Bill's eye with her dazzling smile. Their love story, which began in a chance encounter, is a testament to the unexpected joys life can bring. They were married at the Clearwater, KS Methodist Church on July 6, 1963.

After retiring from the Marine Corps in 1985, Bill began a new chapter in his life. He joined Merrill Lynch in Waco, TX, as a Financial Advisor, where he excelled and eventually became a First Vice President. He also served as the Branch Manager for several years before retiring in 2014. Bill remained active in his community, being involved in the Episcopal and Methodist Churches. He was also a past President of his Rotary Club and Military Officer Association of America chapter.

SERTOMA KITE FESTIVAL

VINCE'S DINING OPTION NOTES

- Terry Black's Barbeque is now open. It is at 228 S Eighth Street, through the entrance is at the rear from 7th Street next to Mary Street. It has an outdoor patio and varied indoor seating. Once thru the entry door, go to your right to enter the serving line which starts with sides and desert and then moves on the meat serving counter and drinks. Pricing is more than local places with sliced brisquet at \$31/lb. as an example but no shortage of customers when I was there.
- <u>The Butcher's Cellar</u> is estimated to be opening in late May. The address is 13701 Woodway Drive, Bldg. #5 in Woodway. It is located across from Oak and Ivy Wine Bar and Bistro and off of HWY 84 service road after Richie Road overpass.

SCARBOROUGH RENAISSANCE FESTIVAL IN WAXAHACHIE

This outdoor festival spans 35 acres where ticketholders step into 16-century village celebrating a visit by King Henry VII and his royal court. Stroll thru the grounds to see performers in Renaissance costumes; vendors hawking goods as flower crowns and period weapons; knights on horseback jousting three time a day; stalls selling fair foods like giant turkey legs and pastries and for those 21 and older, pubs with cold beer and mead. Other attractions include rides and games, acrobatics, and feats such as sword-swallowing and fire whip tricks. It

continues every May weekend including Memorial Day. It is open from 10 a.m. – 7 p.m. and is located at 2511 FM 66. Regular admission is \$38 at the gate and \$32 in advance for adults and teens 13 and up. For children 5 – 12, regular admission is \$18 at gate and \$14 in advance. Children 4 and under are free. MOAA AND TRICARE FOR LIFE SUPPORT

A top advocacy group for service members and military retirees is spending time this spring on Capitol Hill seeking to ward off any discussion of changes to Tricare for Life, to include enrollment fees for the program, which serves as a backstop to Medicare for senior retired personnel. The Military Officers Association of America, or MOAA, has targeted Tricare for Life, the program used by retirees and military spouses 65 and older, as one of its top focus points this year in response to a Congressional Budget Office (CBO) report that included program fees among the options for trimming the federal budget deficit.

The Biden administration's proposed fiscal 2025 budget does not include any changes to Tricare for Life. But the Alexandria, Virginia-based group believes this budget cycle was the right time to educate congressional offices on the importance of Tricare for Life for its users, even though it is not yet facing any changes.

"Absolutely, this is an unconventional issue because there are no current legislative or administration proposals to cut Tricare for Life. However, we wanted to counter the messaging that CBO put out there through their report on ideas for reducing the deficit," said Karen Ruedisueli, MOAA's director of government relations for health affairs.

Tricare for Life, or TFL, was created in 2001 by Congress to serve as a second payee to Medicare for older military retirees and dependent family members. Before then, retirees were able to be seen on a space-available basis at military treatment facilities, but base realignment and closure decisions, as well as military health-care system downsizing, left many without a military health-care option. Under Tricare for Life, retirees are required to sign up for and use Medicare Part B, which requires enrollment fees based on income.

TFL, which requires no fees, picks up any remaining deductibles and copayment costs.

In its Options for Reducing the Deficit 2023 to 2032 published in late 2022, CBO noted that adding enrollment fees of \$575 for an individual or \$1,150 for a family could reduce the deficit by \$15.6 billion over the decade. CBO also noted that introducing out-of-pocket requirements for using TFL would cut the deficit by \$32.6 billion during that time period.

The TFL line items are among several hundred suggestions explored by CBO in the report to reduce the federal deficit, which exceeded \$1.7 trillion in fiscal 2023. But in the report, CBO analysts stressed that the report does not make any recommendations -- it just simply states options. "Inclusion or exclusion of any particular option does not imply an endorsement or rejection by CBO," the report stated.

Nonetheless, MOAA wanted to focus on TFL because the concepts put forth in the report are not "unprecedented," Ruedisueli said. "From fiscal year 2013 to fiscal year 2017, the budget request included five consecutive proposals for Tricare for Life enrollment fees, and the conditions that lead to those recommendations, I think, are out there to a certain extent right now," Ruedisueli said. "There's pressure on the [Defense Department] budget. There are rising military health system costs."

Roughly 200 MOAA members spent April 27 in congressional offices speaking to staff about Tricare for Life and two legislative proposals the organization would like to see passed this year. Those proposals include a change to troops' Basic Allowance for Housing that would cover 100% of the national average for housing costs rather than 95%, the rate determined in 2015; and passage of the Major Richard Star Act.

The administration's fiscal 2025 budget request of \$7.3 trillion includes \$850 billion for the DoD. The budget calls for a 5.2% pay raise for troops and other incentives to bolster junior service members' pay and improve quality of life.

MOAA will continue to educate members of Congress and their staffs on the issues important to their members, especially those that affect all military retirees and career service members.
