THINGS TO REMEMBER AND REFLECT ON IN NOVEMBER:

Nov 4, 1979 - About 500 Iranian militants stormed the U.S. Embassy in Teheran and took 90 hostages (52 Americans) that they held captive for 444 days.

Nov 7, 1811 - General William H. Harrison led 1,000 Americans in defeating the Shawnee Indians at the Battle of Tippecanoe Creek.

Nov 9, 1989 - The Berlin Wall opened up after standing as a symbol of the Cold War.

Nov 10, 1775 - The U.S. Marine Corps was established as part of the U.S. Navy.

Nov 11, 1972 - The U.S. turned over its military base at Long Binh to the South Vietnamese, symbolizing the end of direct American military participation in the <u>Vietnam War</u>.

Nov 13, 1942 - The five <u>Sullivan Brothers</u> were lost in the sinking of the cruiser *USS Juneau* off Guadalcanal causing the U.S. Navy to prohibit close relatives from serving on the same ship.

Nov 15, 1969 - The largest antiwar rally in U.S. History occurred as 250,000 persons gathered in Washington, D.C., to protest the <u>Vietnam War</u>.

Nov 15, 1864 - Union troops under General William T. Sherman burned Atlanta.

Nov 19, 1863 - President delivered the <u>Gettysburg Address</u>

Nov 19-20, 1990 - The Cold War came to an end as leaders of NATO and the Warsaw Pact signed a Treaty on Conventional Forces in Europe

Nov 20, 1943 - The Battle of Tarawa – in eight days of battle U.S. forces took Tarawa and Makin Islands with over 1,000 Americans killed, 2,311 wounded. The Japanese lost 4,700 men.

Nov 22, 1963 - At 12:30 p.m., President John F. Kennedy was assassinated.

Nov 24, 1863 – Chattanooga - "Battle Above the Clouds" - General Ulysses Grant's soldiers scaled heavily fortified Lookout Mountain and defeated the Confederate army.

Nov 25, 1783 - At the end of the Revolutionary War, the last British troops left New York City.

Nov 26, 1789 - President George Washington proclaimed the first American holiday to be Thanksgiving Day

Nov 29, 1864 - Sand Creek Massacre - Colorado volunteers, led by Col John Chivington, murdered at least 100 Cheyenne and Arapahoe Indians, mostly women and children. Company D and K Commanders, 1st Colorado Cavalry refused to obey.

Nov 30, 1782 - A provisional peace treaty was signed between Great Britain and the United States heralding the end of <u>America's War of Independence</u>. The final treaty was signed in Paris on September 3, 1783.

<u>MEMBER SPOTLIGHT – BILL PORTER, 2ND VICE- PRESIDENT</u>



Colonel William Y. 'Bill' Porter, U.S. Army (Ret), received his commission through the Army ROTC program at Texas A&M University in 1978. Bill began his career at Fort Hood as a Platoon Leader and Company Executive Officer, 2nd Battalion/12th Cavalry (Mech),

1st Cavalry Division, and some 30 years later he finished his career as the Chief Information Officer, G-6, U.S. Army Sustainment Command, Rock Island Arsenal, Illinois. Between those assignments he served in numerous positions, mainly as an information officer, but also as a light infantry company commander, advisor to the Army Reserve component, systems analyst, chemical training battalion commander, group operations officer, and deputy inspector general. In the early 2000s he was the Director of Operations, Coalition Provisional Authority-Baghdad at the Federal Deployment Center in Kuwait, followed by duty as the Director of Logistics, J-4, Combined Joint Task Force-Horn of Africa, Djibouti, Africa.

Immediately after his retirement, Bill worked for Kellogg, Brown, & Root (KBR) as a Deputy Project Manager. Subsequently, he worked with MPRI and DynCorp as a mentor for the Afghan Border Police with additional contract duties as Information Management Officer (IMO), ABM Government Services as a Project Manager, Career Pro Global as a resume writer, Cisco Systems and Advanced Systems Design as a contract technical writer, and most recently, Monster.com as a professional resume writer.

VA WORK FORCE IMPROVING NUMBERS

VA health care hiring surge may help the Veterans Health Administration (VHA) rebound from the problems outlined in a recent VA inspector general report on pandemic-era staffing. Things looked bleak during the pandemic throughout U.S. health care systems, and VA was no exception to mounting pressures in providing patient care. The VHA had to alter delivery of services to the over 9 million veterans who relied on care through its 140 hospitals and outpatient centers. And as the largest integrated health care network in the country, VA also serves as the nation's support system during emergencies and national disasters.

Dr. Sheref Elnahal, VA under secretary of health, told MOAA in a recent veteran service organization meeting that he was pleased but cautiously optimistic about the turning of the tide on the staffing. The VHA on boarded well over 403,000 employees since late fiscal year 2022 – the most in history. The increase was a result of focused and proactive hiring and staffing practices. The VHA also saw a decline in employee turnover and retirement rates.

Like other health care systems, VHA still has problems hiring in some occupational areas. In fiscal year 2024, the health system is targeting its efforts at hiring mental health and primary care professionals.

The VA also is working to standardize its hiring process across the enterprise and expand its human resource workforce. Like the VHA's patient-centered or veteran-centric model, the VA hopes to create a candidate-care model that puts individuals and employees at the center of its human resource system.

COLA RATE SET FOR 2024

The rate of 3.2% was released in late October for the annual cost-of-living allowance (COLA) for military retirees, VA disability recipients, Social Security beneficiaries, and others receiving certain federal payments for 2024. It is well below last year's adjustment of 8.7%.

MOAA predicts the upcoming COLA will be 3.2%, down 5.5 percentage points from last year's 8.7% increase. It is just the fifth time in 20 years the adjustment has reached 3% or higher.

MEDICARE PART B RATES FOR 2024

After falling in 2023, the standard Medicare Part B monthly premium will increase by \$9.80 in 2024, the Centers for Medicare and Medicaid Services (CMS) announced Oct. 12.

Last year's decrease came after Medicare limited its coverage of a new, expensive Alzheimer's drug, CMS said. This year's increase comes primarily from "projected increases in health care spending. The annual deductible for Part B beneficiaries will be \$240 in 2024, up from \$226 this year.

The standard premium applies only to individuals with a modified adjusted gross income of \$103,000 or less, or joint filers with income of \$206,000 or less, on their 2022 tax return. Other beneficiaries

pay Income-Related Monthly Adjustment Amounts (IRMAA), which vary by income level.

These rates also increased for 2024, and the rate brackets have been updated:

- Those with income from \$103,001 to \$129,000 on an individual return or from \$206,001 to \$258,000 on a joint return will pay \$244.60 per month, up from \$230.80 in this bracket in 2023.
- Those with income from \$129,001 to \$161,000 on an individual return or from \$258,001 to \$322,000 on a joint return will pay \$349.40 per month, up from \$329.70 per month in this bracket in 2023.
- Those with income from \$161,001 to \$193,000 on an individual return or from \$322,001 to \$386,000 on a joint return will pay \$454.20 per month, up from \$428.60 in this bracket in 2023.
- Those with income from \$193,001 to \$500,000 on an individual return or from \$386,001 to \$750,000 on a joint return will pay \$559 per month, up from \$527.50 in this bracket in 2023.
- Those with income above \$500,000 on an individual return or above \$750,000 on a joint return will pay **\$594 per month**, up from \$560.50 in this bracket in 2023.

Married beneficiaries who lived with their spouses during at least part of the taxable year but file separate tax returns have their own payment scale: Those with modified adjusted gross income between \$103,001 and \$397,000 pay a \$559 monthly premium, while those with income at or above \$397,000 pay \$594 per month.

Because the 2024 income-adjusted rates are based on 2022 tax records, they may not accurately reflect the financial situation of all beneficiaries. If your income level has decreased in recent years, you can file Form SSA-44 with the Social Security Administration to request an adjustment.

Applicants must identify a "Life-Changing Event" connected with the income reduction. Examples include marriage or divorce, the death of a spouse, change in work status, or a lump-sum payment or settlement from a previous year resulting in a temporary income increase.
