2025 HOT MOAA CHAPTER VISION & OBJECTIVES

The following objectives and vision were presented by the Objectives Committee and approved by the Board of Directors. Each of the objectives are aligned to the chapter's Mission Statements in the Bylaws. Mission statements are included for reference and paraphrased for brevity.

VISION: Foster member camaraderie and become the recognized leading veterans' organization (Heart of Texas Chapter Military Officers Association Brand) in supporting uniformed services veterans (active/retired/honorably discharged), their families and dependents in Texas by:

- Becoming a central Texas legislative catalyst, advocating for proposed legislation "affecting the career force, retired community, and veterans of the uniformed services," in accordance with the national organization's purpose.
- Participating in and being represented at all veterans' activities in central Texas

HOT MOAA CHAPTER OBJECTIVES

Mission statements are included for reference and paraphrased for brevity -

Mission Statement 1 - Support U.S. and Texas legislation beneficial to veterans, their spouses and dependents the spouses and orphans of deceased veterans.

 Objective: Identify, advocate and promote National MOAA and Texas MOAA legislative priorities. Mission Statement 2 – Foster camaraderie among all members of the Chapter.

- *Objective:* Venerate shared patriotism and service to the country through programs, speakers, and activities about subjects relevant to military, veterans, and country.

Charles A. Weaver III serves as Associate Dean for Sciences in the College of Arts and Sciences at Baylor University. He is a Professor of Psychology and Neuroscience and served as

chair of the department for eight years before joining the Dean's Office. He has published dozens of scientific articles, two books and delivered hundreds of professional and scientific presentations, primarily in the areas of memory, cognition, and eyewitness identification. He has served as a forensic expert in more than 30 states. He was elected "Fellow" by both the Association for Psychological Science and the Psychonomic Society. In 2020, he was named "Master Teacher" by Baylor University, one of only 29 individuals so honored in the 175 year history of the university. His presentation was on how we remember and forget and was well received by the Chapter.

"The Congressional Budget Office (CBO) has once again targeted TRICARE For Life (TFL) in its biennial report outlining options for reducing the deficit. The December 2024 report highlights savings that could be achieved by introducing a TFL enrollment fee or minimum out-of-pocket cost requirement. Similar concepts have been presented in past CBO reports, which are issued every two years to provide information to lawmakers confronting budgetary challenges." HERE'S WHY YOU SHOULD DOWNLOAD YOUR MILITARY HEALTH RECORDS BEFORE APRIL 1

TRICARE users have less than two months to download their medical records via the TRICARE Online Patient Portal, which will decommission April 1 as part of DoD's move to the MHS GENESIS electronic health record.

These records include lab results, immunizations, medication lists, allergies, and a range of other medical data. Your military treatment facility providers will continue to have access to your complete health records.

"If you moved from one duty station to another, and one military hospital or clinic used [the TRICARE Online Patient Portal] and the other used MHS GENESIS, your records in MHS GENESIS may have gaps," according to a Jan. 22 Defense Health Agency (DHA) statement on the record transition.

Beneficiaries should download their records before the changeover to ensure they have a complete digital copy of their legacy health records for personal use.

"When it comes to medical care, you are your own best advocate – and there's no way to predict what records you'll need to make your case," said Lila Quintiliani, MOAA's program director for financial and benefits education and counseling.

"Get copies of what's available for you and your family and store them somewhere safe – one digital version on one old laptop may not be the best solution."

Downloading Your Records

TRICARE Online Patient Portal users can download step-by-step instructions, with visual aids, at this link (PDF). Begin by logging in at TRICAREOnline.com – those without a Common Access Card (CAC) or DS Logon credentials can access their materials by following instructions at the "Create New Account" prompt.

After clicking the "Health Record" option on the homepage, choose "Download My Data" and select the relevant dates, categories, and individuals. Materials dating back 30 years are available to beneficiaries, according to the DHA statement, and include full records for children up to age 12 and limited records from ages 12 to 17. You can request printed results for adolescents from your child's clinic or provider.

Note that medical record downloads can take up to several hours.

Other Options

Beneficiaries may also request physical copies of their records from the records management office of their military medical facility. Forms must be filled out in person, and beneficiaries will need to return to the facility at a designated time to retrieve the records. Beginning April 1, if you want your legacy health records, you'll have to request a physical copy from your military hospital or clinic's records management office.

NEW VA SECRETARY APPOINTED

Collins Confirmed as Secretary of Veterans Affairs: Following a confirmation vote of 77–23 in the Senate, Douglas A. Collins has been sworn in as the 12th secretary of Veterans Affairs. He is the first post 9/11 veteran to serve in this Cabinet position. He served in the Navy and is currently a colonel and chaplain in the Air Force Reserve. Collins is also a former U.S representative from Georgia.

In a message to veterans and VA employees, he outlined his approach to include delivering timely access to care and benefits for every eligible individual, focusing on customer service and convenience, challenging the status quo, and celebrating great performance by VA employees but holding accountable those who fall short of the mission. HOUSE PASSES VETERAN HOMELESSNESS BILL

The House passed VFW-supported H.R. 965, Housing Unhoused Disabled Veterans Act. This bill would exclude VA disability compensation from income calculations for housing programs supported by the U.S. Department of Housing and Urban Development. Veterans with injuries or illnesses resulting from military service may have significant barriers to employment and be at a higher risk for homelessness. The risks may also increase for those with higher disability ratings. Excluding this earned compensation would facilitate greater veteran eligibility for supported housing programs. The Senate will now need to consider for action. From Feb 17, 2025, VFW Action Corps Weekly issue.

U.S. Senator John Cornyn
