"Liberty must at all hazards be supported. We have a right to it, derived from our Maker. But if we had not, our fathers have earned and bought it for us, at the expense of their ease, their estates, their pleasure, and their blood." – John Adams, 1765

THINGS TO REMEMBER AND REFLECT ON IN MAY:

May 1, 1960 - An American U-2 spy plane flying at 60,000 feet was shot down over Sverdlovsk in central Russia on the eve of a summit meeting between President Eisenhower and Soviet Russia's Premier Khrushchev

May 2, 2011 - U.S. Special Operations Forces killed Osama bin Laden during a raid on his secret compound in Abbottabad, Pakistan

May 4, 1970 – At Kent State University, four students were killed, and 11 others were wounded by National Guardsmen who opened fire on a crowd of 1,000 students protesting President Richard Nixon's decision to invade Cambodia.

May 5, 1961 -Alan Shepard became the first American in space piloting *Freedom 7* during a 15-minute 28-second suborbital flight that reached an altitude of 116 miles above the earth.

May 6, 1937 - The German airship Hindenburg burst into flames at 7:20 p.m. as it neared the mooring mast at Lakehurst, New Jersey

May 7, 1915 - The British passenger ship *Lusitania* was torpedoed by a German submarine off the coast of Ireland, killing 1,198 passengers

May 7, 1954 - The French Indochina War ended with the fall of Dien Bien Phu, in a stunning victory by the Vietnamese over French colonial forces in northern Vietnam. The country was then in divided in half at the 17th parallel, with South Vietnam created in 1955.

May 7, 1992 - The 27th Amendment to the U.S. Constitution was ratified, prohibiting Congress from giving itself pay raises.

May 8, 1942 – The Battle of the Coral Sea began in which Japan would suffer its first defeat of the war

May 10, 1869 - The newly constructed tracks of the Union Pacific and Central Pacific railways were first linked at Promontory Point, Utah

May 11, 1969 - During the Vietnam War, the Battle of "Hamburger Hill" began. After finally securing the objective, American military staff decided to abandon the position.

May 12, 1949 - Soviet Russia lifted its blockade of Berlin

May 13, 1846 - At the request of President James K. Polk, Congress declared war on Mexico. The controversial struggle eventually cost the lives of 11,300 U.S. soldiers

and resulted in the annexation of lands that became parts of Oklahoma, New Mexico, Arizona, Nevada, California, Utah and Colorado. The war ended in 1848 with the Treaty of Guadalupe Hidalgo.

May 14, 1942 - During World War II, an Act of Congress allowed women to enlist for noncombat duties in the Women's Auxiliary Army Corps (WAAC), the Women Appointed for Voluntary Emergency Service (WAVES), Women's Auxiliary Ferrying Squadron (WAFS), and Semper Paratus Always Ready Service (SPARS), the Women's Reserve of the Marine Corp

May 17, 1954 - In Brown v. Board of Education, the Supreme Court unanimously ruled that segregation of public schools "solely on the basis of race" denies black children "equal educational opportunity" even though "physical facilities and other 'tangible' factors may have been equal. Separate educational facilities are inherently unequal."

May 20, 1927 - Charles Lindbergh took off at 7:52 a.m. from Roosevelt Field, Long Island attempting the first solo nonstop flight between New York City and Paris.

May 20, 1932- Amelia Earhart became the first woman to fly solo across the Atlantic.

May 21, 1881 - The American Red Cross was founded by Clara Barton.

May 24, 1844 - Telegraph inventor Samuel Morse sent the first official telegraph message, "What hath God wrought?"

May 29, 1865 - Following the American Civil War, President Andrew Johnson issued a proclamation granting general amnesty to Confederates.

May 30, 1943 – During, the Aleutian Islands off the coast of Alaska were retaken by the U.S. 7th Infantry Division. US causalities – 552 killed & 1,140 wounded. Japanese killed – 2352

May 31, 1889 - Over 2,300 persons were killed in the Johnstown flood in Pennsylvania. Heavy rains throughout May caused the Connemaugh River Dam to burst sending a wall of water 75 feet high pouring down upon the city

OUR MAY 15 GUEST SPEAKER – DR. DANIEL J. PACK, DEAN, BAYLOR SCHOOL OF ENGINEERING AND COMPUTER SCIENCE Dr. Pack will speak on military applications of 3-D printing and communications networks.

Dr. Pack holds a Bachelor of Science degree in Electrical Engineering from Arizona State University, a Master of Science degree in Engineering Sciences from Harvard University, and a Ph.D. in Electrical Engineering from Purdue University. He spent a year as a visiting scholar at the Massachusetts Institute of Technology-Lincoln Laboratory.

He previously served as the Dean of the College of Engineering and Computer Science at the University of Tennessee, Chattanooga (UTC). Dr. Pack was also a Professor and Mary Lou Clarke Endowed Chair of the Electrical and Computer Engineering Department at the University of Texas, San Antonio, and a Professor (now Professor Emeritus) of Electrical and Computer Engineering at the United States Air Force Academy (USAFA), CO, where he directed the Academy Center for Unmanned Aircraft Systems Research.

With over 25 years of experience in autonomous systems and related technologies, Dr. Pack has earned numerous awards and has co-authored seven textbooks on embedded systems and published over 160 scholarly works on unmanned systems, cooperative control, robotics, pattern recognition, and engineering education

<u>MEMBER SPOTLIGHT – JACK ROCHELLE,</u> LT COL, USAF (RET)



Jack Rochelle grew up in a small town in West Tennessee north of Memphis. His Mother was a 7th and 8th grade arithmetic teacher and his Dad was principal of the Elementary School. By the age of 14

Jack was delivering the morning Memphis newspaper in town and by age 15 Jack was working part-time as a radio Disc Jockey at the local radio station, a job he continued through college.

Jack was the Valedictorian of his high school class in 1961 and after graduation attended Memphis State University. At that time, all freshman and sophomore men were required to enroll in the Air Force Reserve Officer Training Corps (ROTC), so Jack had a blue Air Force uniform in his closet four years before receiving his commission on graduation in 1965.

He completed pilot training at Randolph Air Force Base (AFB) flying the T-28 trainer, H-19 and H-43 helicopters. After graduation, his next assignment was to Grand Forks AFB for missile site support in the UH-1F helicopter. Then Jack had separate tours to Vietnam in 1967 and 1969-70 as a UH-1P helicopter pilot with the 20" Special Ops Sq. Those tours ended in December 1969 after Jack and crew were shot down and he evaded enemy troops with his injured crew until rescue.

After regaining flight status, his was assigned to Randolph AFB flying the T-38, then on to Charleston AFB as a C-141 pilot. In 1973, pilot drawdown resulted in a new assignment to Little Rock AFB as a Titan II site commander and later Chief of the Command Post. In 1977, a new assignment back to Charleston in the C-141, followed with new duty in Command and Control as Command Post Chief.

Following promotion to Lt Col in 1981, Jack was assigned to Military Airlift Command (MAC) Headquarters as a Senior Airlift Controller in the Command Center and later as Chief, Operations Systems Management. In that position, Lt Col Rochelle was responsible for Stan/Eval and functional management of MAC Base Operations, Command Posts, Airlift Control Element (ALCE) deployment and Airspace management.

In 1986, Jack became Airfield Manager at Scott AFB well as project director of the annual Scott Open House and Air Show, which hosted over 25,000 guests from the St. Louis area over the two day show. One of his project officers was Lt. Col Barbara Hair, a Family Practice nurse, AF flight nurse and the Health Promotion Coordinator for the Regional Hospital at Scott. She was the person responsible for maintaining the medical support for the base open house.

Following the open house in 1988, she brought her after action report in person to Jack's office. Jack's secretary, noticing that she was not wearing a wedding ring, called her and held out the phone and said "talk to her!" and as they say, the rest is history. We were married in July 1989.

We had planned to retire in June 1991, as we both had been accepted at professional schools, Barbara to University if North Texas Medical School in Fort Worth and Jack to Law school at Memphis. Due to the Mid-East war, medical personnel were extended a year, but her medical school held the position. Jack retired and started law school in 1991.

While in the Air Force, Jack and Barbara had obtained Masters Degrees and had graduated from the Air Force Air War College. At retirement, Jack was serving as liaison between Scott AFB and Illinois Department of Transportation in the potential development of a joint use plan with Scott AFB, which is now the Mid America Airport.

Jack graduated from law school with honors in 1994 and passed the Texas bar exam, and Barbara finished med school in 1996 with a residency at the University of Texas. During her residency, she completed her Masters of Public Health degree.

Jack was working with a law firm in Fort Worth and Barbara was hired by Scott and White in Waco following her residency. Following a move to Waco, Jack began working with the Veteran's Administration Regional office and retired in 2008. Jack was the Vice President of the HOT MOAA from 2002-2004 as well as member of Board of Directors. He also served as President of The Lone Star Retired Officers Club in Fort Worth in 1998. Jack has continued to participate with Baylor Law School at veteran's clinics and Texas lawyers for Texas veterans.

Barbara continues to work with Concentra Medical and is a member of the Board of Directors of the McLennan County Medical Society. Their blended family consists of four children, six grandchildren and three great grands.

On his 80" birthday 2 years ago, Jack was presented with a proclamation from the Mayor of Waco declaring "Jack Rochelle Day" in honor of his continuing volunteer work for the local veteran's community.

MOAA LEGISLATIVE CONCERNS

"The Congressional Budget Office (CBO) has once again targeted TRICARE For Life (TFL) in its biennial report outlining options for reducing the deficit. The December 2024 report highlights savings that could be achieved by introducing a TFL enrollment fee or minimum out-of-pocket cost requirement. Similar concepts have been presented

in past CBO reports, which are issued every two years to provide information to lawmakers confronting budgetary challenges." See last month's newsletter for more information.

RETIREE COLA PREDICTIONS REMAIN STEADY AS INFLATION FEARS LOOM

Next month's release of key inflation figures should offer military retirees, Social Security recipients, and other federal beneficiaries an early glimpse of what trade-policy changes could mean for their annual cost-of-living adjustment.

Two predictions based on the April release of March inflation data put the 2026 COLA increase at 2.3% and 2.2%, in line with previous estimates. However, both made clear the numbers did not reflect any price changes resulting from recent tariffs; the first figures to include even a small amount of that data will be released in May.

Doing the Math

A 2.3% COLA would require the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) to rise in the next few months from its current level of 1.5% over the annual baseline figure. The average of the last three monthly CPI-W figures of the fiscal year (July, August, and September) is used to calculate the COLA.

Last year, the CPI-W rose from 1.7% in March 2024 to an average of 2.5% over those last three months – much lower than previous years' figures, which led to near-record COLAs.

Details Matter

No matter the eventual impact of trade policy on prices, it's important to keep these factors in mind regarding inflation and the potential pay adjustment:

 Watch the numbers: Media reports on monthly inflation figures rarely mention the CPI-W, instead reflecting the CPI "for all urban consumers," or CPI-U. These figures pull from different data sets, giving greater weights to different products.

- Trends and timing: While upcoming releases may offer a glimpse at a possible COLA, only the last three releases of the fiscal year determine the raise.
- **Personal spending:** While the CPI-W pulls from a "basket" of consumer spending designed to reflect overall purchasing power, an individual's budget may not fully align with the data set. If food prices rise but other costs stay stable, for example, a retiree with a larger-than-average food budget may not see as much relief from their COLA increase.

Why MOAA Tracks COLA

Publishing monthly updates to the CPI-W at MOAA.org allows MOAA members and others to use the information in their financial planning. However, MOAA's main interest in tracking COLA is to maintain the earned retirement benefit for those who served and their families.

Without continued inflation adjustment, this benefit would lose its value in short order. And while that may seem obvious, it hasn't stopped lawmakers from attempting to change COLA calculations or make other budget-based decisions that would weaken retirees' buying power.

Protecting this benefit has long been a top MOAA priority. And while no current legislation threatens these adjustments, ongoing budget constraints and an ever-present inclusion of COLA changes in a regular Congressional Budget Office report on deficit-reduction options means the issue simply cannot fall off the radar.
